2010 AQUAFEST TENNIS TOURNAMENT CONDITIONS

Players are advised to retain this part of the entry form for their own information, noting the entry conditions.

Aquafest Activity Agreement:

We wish to participate in Aquafest. The organization or individual(s) identified above shall, as a condition of participation, indemnify and hold harmless, the City of Lake Stevens, the County of Snohomish, and the non-profit corporation known as the Aquafest Association, its officers, directors, and committee members, from any and all claims, suits, losses, damages or expenses on account of bodily injuries or property damage arising out of their participation in the Aquafest celebration. Further, the said individual(s) or organization will defend, on behalf of the City, County, and the Aquafest Association, all claims or suits for bodily injury or property damage arising out of their participation in the Aquafest celebration. I also understand that any sponsor may, for publication, or promotion, use my name or pictures of my participation in this event without obligation or liability to me.

Age Eligibility: Entrants in junior events must supply their birth dates and produce their birth certificates if requested. Eligibility for events is:

Veterans: Born on or before 7/23/1975

18 & Under: Born on or after 7/26/1991

16 & Under: Born on or after 7/26/1993

Withdrawals: Withdrawals from events after the entry closing date will not be refunded.

Entries: No player shall be permitted to enter in more than three events without the express permission of the Tournament Director; and if entered in three events, one must be a doubles event.

Trophies: Trophies will be awarded to the winner/s and runner/s-up of the main draw if the main draw of the event has 8 or more players/pairs. In the event of there being less than 8 players/teams a trophy shall only be presented to the winner/s of that event.

Consolations: A consolation (feed-in) draw will be available for losers up to the quarterfinals in all events using the knock-out format.

Matches: All singles and doubles events shall be played using the knockout format and all matches shall be the best of three tie break sets (12 point tie-breaker). All Feed In matches will be best of two tie break sets with a 12 point match tie breaker at one set all. Dependent on entry numbers, some event formats may differ from those advertised.

Tournament Director, may assign a partner for those doubles entries where no partner is specified but this does not impose any obligation on the Tournament Director to find a partner.

Exemptions: Players must be available at all times during the tournament. No time exemptions will be granted.

Entry Fees: \$15.00 / person/event

Balls: For all knockout matches, two new balls shall be supplied. If in the opinion of the Tournament Director the balls become unduly worn during a match, the Tournament Director may authorize the supply of two new balls. Good used balls may be used for Feed-in Championships. For Round Robin events three balls for a group of four players or four balls for a group of five players shall be supplied.

Umpiring: All matches will be umpired by the contestants themselves however the Tournament Director reserves the right to assign an umpire to a match/es.

TOURNAMENT RULES AND POLICIES

This tournament will be conducted in accordance with the laws of the game adopted by the United States Tennis Association. You acknowledge that as a participant in this tournament you are required to comply with various rules and policies. If you do not understand the above rules and policies and /or your obligation under them, you should seek clarification from the Tournament Director before you complete this form.
